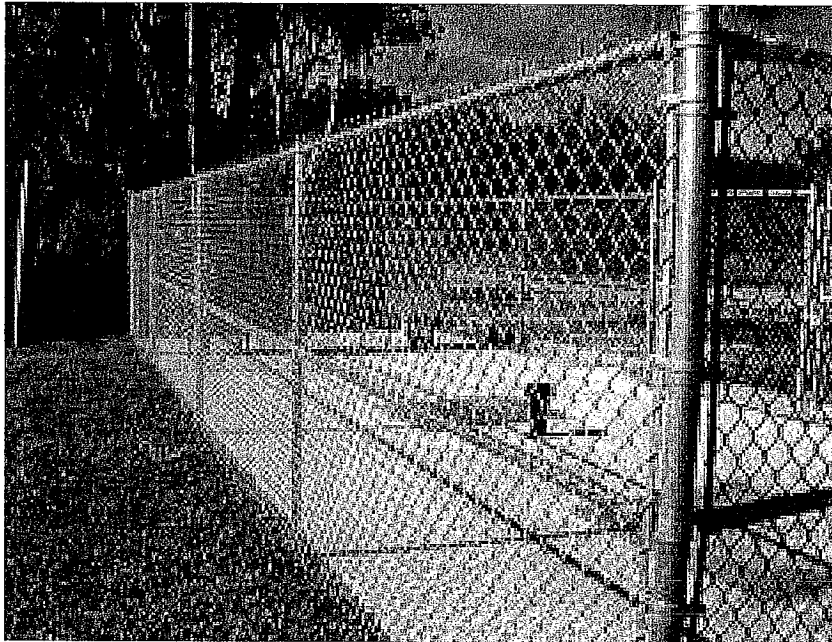

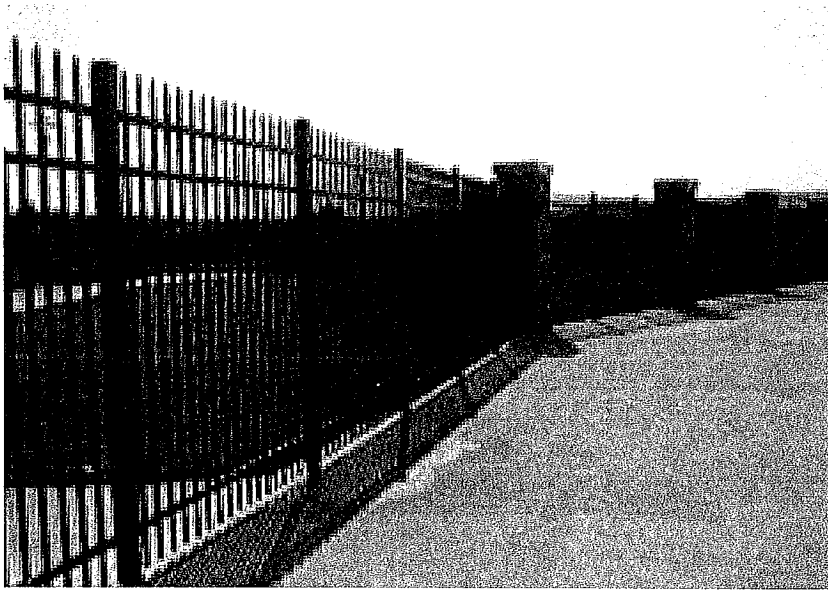

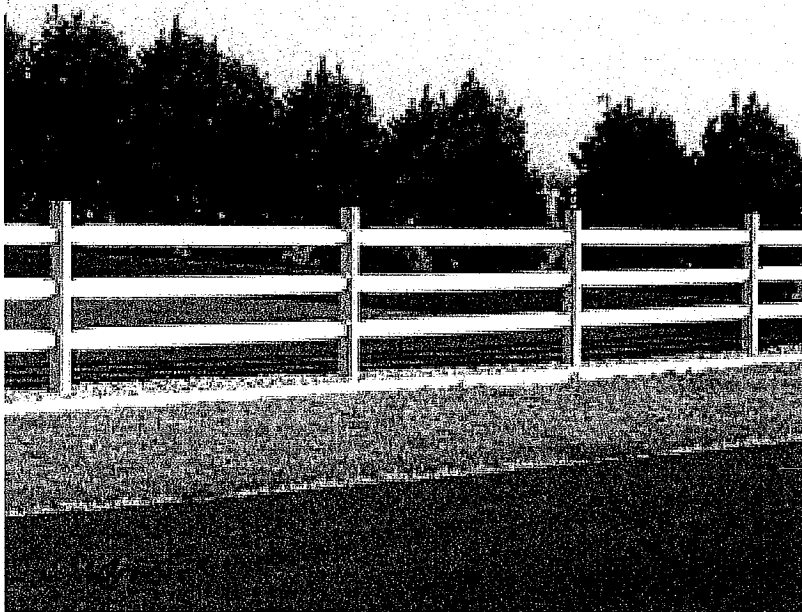
Tube Steel Fence:



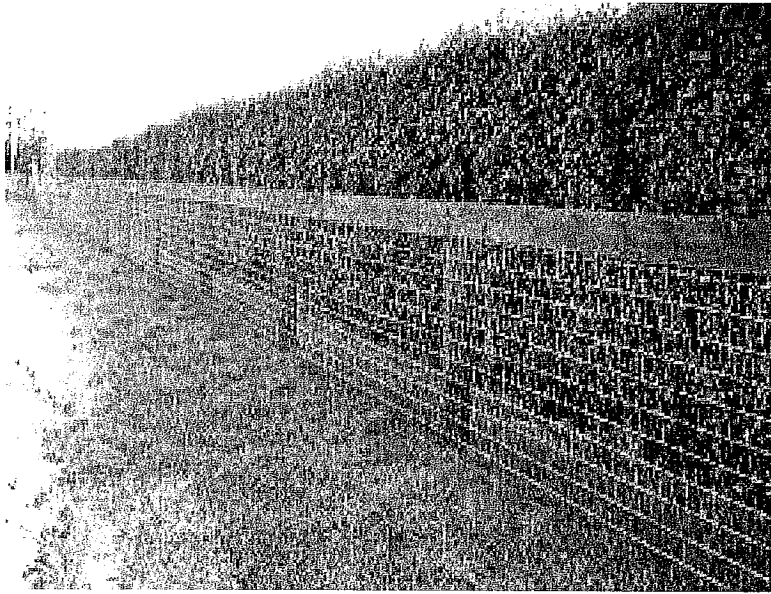

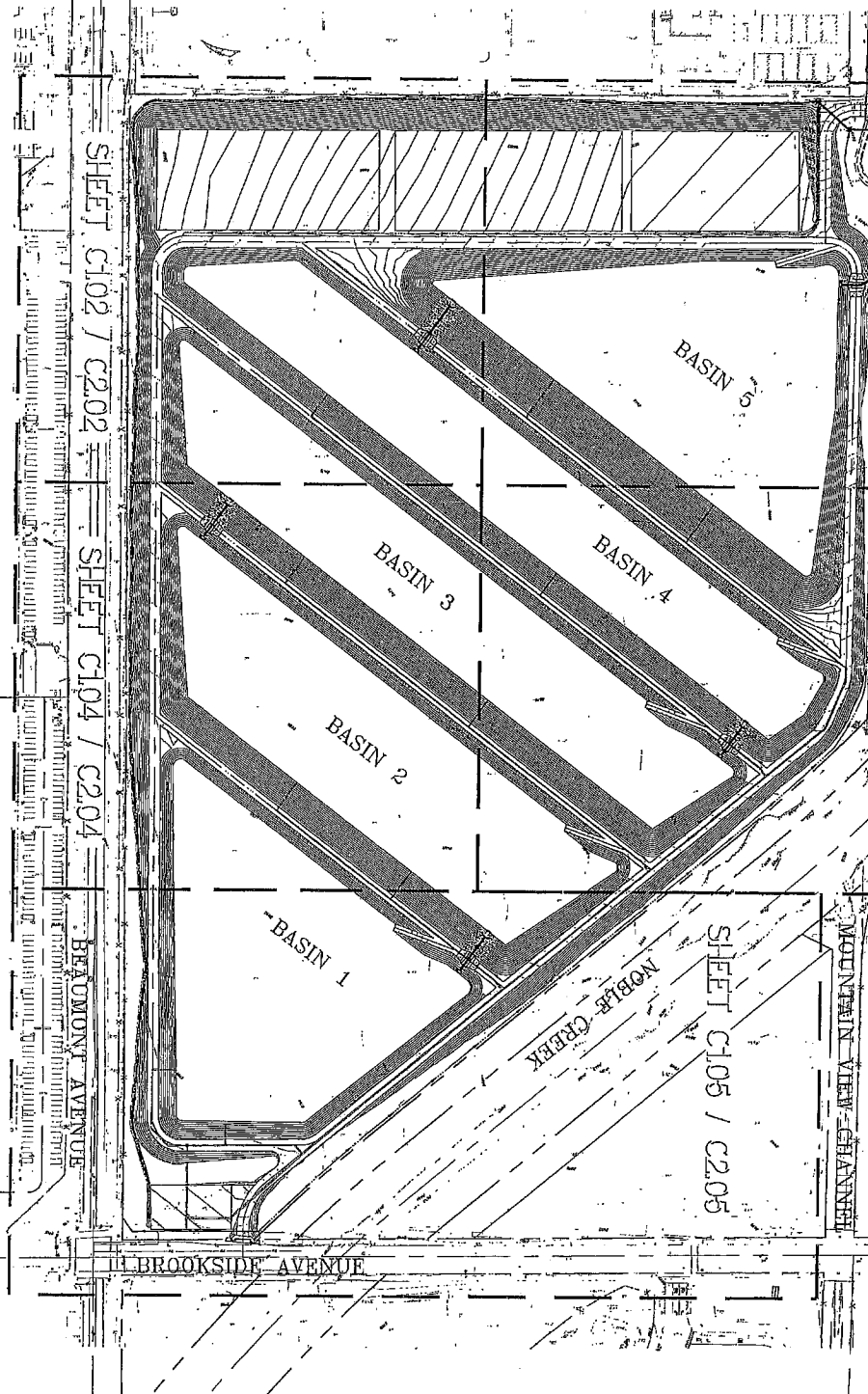
