1. **Call to Order and Flag Salute:** The scheduled meeting of the San Gorgonio Pass Water Agency Water Conservation and Education Committee was called to order by Committee Chair Thompson in the Agency Board Room, 1210 Beaumont Avenue, Beaumont, California, at 1:40 pm, October 10, 2019. Director Thompson led the Committee in the Pledge of Allegiance.
2. **Adoption and Adjustment of the Agenda.** The Agenda was adopted as published.
3. **Public Comment:** Madeline Blua of Yucaipa Valley Water District noted that the committee that produces the Inland Solar Challenge will produce a brochure this year. There were no other members of the public who wished to speak at this time.
4. **Approval of the Minutes of the August 8, 2019 Meeting.** Director Lehtonen moved, seconded by Director Thompson, that the minutes of the August 8, 2019 committee meeting be approved. Motion passed 2-0, with Director Ball not yet arrived.
5. **Status Report on IERCDC Programs.** A copy of the July and August reports from IERCDC were included in the agenda package. In addition, General Manager Davis passed out a separate report on use of the aquifer models. After discussion, the Board had a number of questions, and directed General Manager Davis to invite IERCDC to the next meeting to report on their progress, especially with the aquifer models.
6. **Discussion of Social Media Campaign.** The Committee noted that the Agency now has more followers and indicated that they are pleased with the progress of this campaign. It was noted again that this is a long-term campaign, and that slow progress is acceptable.
7. **Discussion of State of the Water Supply Event.** The Committee further discussed the planned event. They would like to consider holding it in the February through May time frame and might make it part of a dedication

ceremony for the Fiesta recharge facility. Various topics discussed that could be included in the event are water conservation, Sites Reservoir, Delta Conveyance, an update on local water supplies, and water rates and/or the proposed capacity fee. The Committee discussed whether the event should be more educational or more an event to promote the Agency, but made no final decisions.

8. **Adjournment.** After deciding that there will be no meeting next month, Chair Thompson adjourned the meeting at 2:38 pm.
