**November 23, 2020**

In an effort to prevent the spread of COVID-19 (Coronavirus), and in accordance with the Governor's Executive Order N-29-20, this meeting was held via Zoom.

- 1. Call to Order, Flag Salute and Roll Call:** The Finance and Budget Workshop of the San Gorgonio Pass Water Agency Board of Directors was called to order by Vice Chair of the Finance and Budget Committee David Fenn at 1:30 pm, November 23, 2020. Vice Chair Fenn led the Pledge of Allegiance to the flag. A quorum was present.
- 2. Adoption and Adjustment of Agenda:** The agenda was adopted as posted.
- 3. Public Comment:** Vice Chair Fenn asked if anyone connected to the meeting wished to make a comment; no members of the public requested to speak at this time.
- 4. New Business:**
  - A. Ratification of Paid Invoices and Monthly Payroll for October, 2020 by Reviewing Check History Reports in Detail: After review and discussion, a motion was made by President Duncan, seconded by Vice Chair Fenn, to recommend that the Board ratify paid monthly invoices of \$2,480,687.37 and payroll of \$45,059.73 for the month of October, 2020, for a combined total of \$2,525,747.10. The motion passed 6 in favor, no opposed, with Director Thompson absent, by roll-call vote.
  - B. Review Pending Legal Invoices: After review and discussion, a motion was made by Director Ball, seconded by Director Castaldo, to recommend that the Board approve payment of the pending legal invoice for October, 2020 for

\$7,902.77. The motion passed 6 in favor, no opposed, with Director Thompson absent, by roll-call vote.

- C. Review of October, 2020 Bank Reconciliation: After review and discussion, a motion was made by President Duncan, seconded by Director Stephenson, to recommend that the Board acknowledge receipt of the Wells Fargo bank reconciliation for October, 2020 as presented. The motion passed 6 in favor, no opposed, with Director Thompson absent, by roll-call vote.
  - D. Review of Budget Report for October, 2020: Finance Manager Tom Todd briefly reviewed the report, and noted the current net budget balances of the Debt Service Fund and the General Fund and commented that these balances will look better at the end of December. After further review and discussion, a motion was made by Director Stephenson, seconded by President Duncan, to recommend that the Board acknowledge receipt of the Budget Report for October, 2020. The motion passed 6 in favor, no opposed, with Director Thompson absent, by roll-call vote.
  - E. Discussion of Tax Revenue: General Manager Lance Eckhart led a presentation and discussion about the difference between the unrestricted, General Fund tax revenue and the restricted Debt Service Fund tax revenue. General Manager Eckhart represented these funds by a green pail for the General Fund and a red pail for the Debt Service Fund. Other sources of revenue were mentioned, but this presentation concentrated on tax revenue and the uses of each fund and their associated reserves. The Board and the public asked questions and discussed these concepts.
