- 1. Call to Order and Flag Salute: The scheduled meeting of the San Gorgonio Pass Water Agency Water Conservation and Education Committee was called to order by Committee Chair Thompson in the Agency Board Room, 1210 Beaumont Avenue, Beaumont, California, at 1:30 pm, August 8, 2019. Director Thompson led the Committee in the Pledge of Allegiance.
- 2. Adoption and Adjustment of the Agenda. The Agenda was adopted as published.
- **3. Public Comment:** There were no members of the public present who wished to address the Committee at this time.
- 4. Approval of the Minutes of the June 13, 2019 Meeting. Director Lehtonen moved, seconded by Director Thompson, that the minutes of the June 13, 2019 committee meeting be approved. Motion passed 3-0.
- 5. Status Report on IERCD Programs. A copy of the June report from IERCD was included in the agenda package. The Committee was pleased with the number of programs given by IERCD this year. The Committee asked the General Manager to get answers from IERCD on the following questions: Were the groundwater models used this year? Did IERCD clean them over the summer and deliver them back to the high schools? The Committee would also like IERCD to include information on the groundwater models in its monthly report, to the extent that the IERCD is aware of any.
- 6. Discussion of Social Media Campaign. The Committee asked the General Manager to place social media icons on the Agency's web site so that the social media sites may be accessed from the web site. They also directed the General Manager to add the Agency's web site to the Instagram site; it appears to be absent.
- 7. Discussion of State of the Water Supply Event. The Committee wants to consider use of the Four Seasons ballroom as a potential site for this planned event. The Committee would like to hold the event in late winter or early

spring 2020, and would like to start focusing in on some dates at the next meeting. After a brief discussion of PFAS, the Committee recognized that this may be an issue that should be discussed at the event. This could depend on the media attention given to PFAS in the next few months. The Committee sees a number of issues that could be addressed at the event—current water supplies, future water supplies, 2020 hydrology, the Delta Conveyance project, Sites Reservoir, SGMA, and water quality. It is not likely that all will be addressed but the Committee and General Manager will discuss which issues are the most important to address at the event.

8. Adjournment. After deciding that there will be no meeting next month, Chair Thompson adjourned the meeting at 2:23 pm.
