- 1. Call to Order and Flag Salute: The scheduled meeting of the San Gorgonio Pass Water Agency Water Conservation and Education Committee was called to order by Committee Chair Thompson in the Agency conference room, 1210 Beaumont Avenue, Beaumont, California, at 1:30 pm, February 13, 2020. Director Thompson led the Committee in the Pledge of Allegiance.
- 2. Adoption and Adjustment of the Agenda. On recommendation from General Manager Davis, the Committee reversed agenda items 5 and 6, placing discussion of sponsorship of the Inland Solar Challenge before the status report on IERCD programs.
- **Public Comment:** There were no members of the public who wished to speak at this time.
- 4. Approval of the Minutes of the December 12, 2019 Meeting. Director Ball moved, seconded by Director Thompson, that the minutes of the December 12, 2019 committee meeting be approved. Motion passed 2-0 with Director Lehtonen absent.
- brochure for this year's event and a sponsorship package were included in the agenda package. Janett Robledo, Cecilia Contreras, Jennifer Ares, and Devin Arciniega from the Inland Solar Challenge Committee were present at the meeting and Ms. Robledo made a presentation on this year's program. She noted that the Committee has taken recommendations from the Agency and implemented them, such as forming a 501c3 organization, reaching out for more participation among students, and lengthening the PSA's produced by the students. She noted that the Committee will likely take a small loss this year due to the cost of creating a 501c3 organization. Director Thompson asked if the Committee would like to request a larger sponsorship than the \$4000 previously requested, and she answered in the affirmative. Director Thompson moved to sponsor the event at the \$5000 level. The motion died

for lack of a second. Director Ball explained that he did not feel that sponsorship of this event represented good stewardship of Agency funds due to the relatively small level of participation. With no action taken, General Manager Davis announced that he would bring this item to the Board without a recommendation from the Committee.

- 6. Status Report on IERCD Programs. A copy of the December and January reports from IERCD were included in the agenda package. Jasmine Orozco Clark was also present in response to a request from the Committee at the December meeting. Ms. Clark reviewed recent actions with the groundwater models and shared photos of it being used with a second grade class. She noted that the IERCD has already booked more programs than budgeted for this year. General Manager Davis assured her that IERCD would be paid for the programs already booked but not contracted for. The Committee asked to discuss a larger budget for this at the next meeting. Director Thompson inquired about integrating the IERCD's work into the Inland Solar Challenge to better leverage both programs. Ms. Clarke responded that she already works with the Inland Solar Challenge Committee and that there are likely other ways in which IERCD and the Inland Solar Challenge Committee could work together to add value to both programs. Director Thompson indicated that he would like to discuss this further at the next meeting.
- 7. **Discussion of Social Media Campaign.** At the request of Chairman Thompson, this item was tabled to the next meeting.
- 8. Discussion of Potential Dedication Ceremony for Fiesta Recharge Facility. At the request of Chairman Thompson, this item was tabled to the next meeting.
- 9. **Discussion of State of the Water Supply Event.** At the request of Chairman Thompson, this item was tabled to the next meeting.
- **10. Adjournment.** After deciding that there will be a meeting next month, Chair Thompson adjourned the meeting at 2:46 pm.


