- 1. Call to Order and Flag Salute: The scheduled meeting of the San Gorgonio Pass Water Agency Water Conservation and Education Committee was called to order by Committee Chair Thompson in the Agency conference room, 1210 Beaumont Avenue, Beaumont, California, at 1:30 pm, March 12, 2020. Director Thompson led the Committee in the Pledge of Allegiance.
- **2. Adoption and Adjustment of the Agenda.** The Agenda was adopted as published.
- **Public Comment:** There were no members of the public who wished to speak at this time.
- 4. Approval of the Minutes of the February 13, 2019 Meeting. Director Thompson moved, seconded by Director Lehtonen, that the minutes of the February 13, 2020 committee meeting be approved. Motion passed 2-0 with Director Ball absent.
- 5. Discussion of Adding to Number of IERCD Programs for this Year. A copy of the SGPWA Groundwater Model Update for 02/13/3030 was included in the agenda packet. Staff provided the members of the committee and of the general public a copy of the IERCD Water Conservation Programs Report, dated February 2020. He stated that IERCD was contracted for 36 classroom presentations, they have currently taught 38, and have an additional 3 presentations scheduled. It was agreed upon at the last meeting to pay for those additional presentations. Director Thompson remarked that during the last committee meeting there was discussion about integrating the IERCD's work into the Inland Solar Challenge to better leverage both programs. Ms. Jasmine Orozco Clarke at the time responded indicated that there are ways that we could work together to add value to both programs. Director Thompson mentioned that he would like to up the number of the current Prezi's as well as have discussion on the potential of partnering with ISC and IERCD for local school participation in the ISC challenge. At the request of Chairman Thompson, this item was tabled to the next meeting. He asked that

an invitation to attend the meeting is extended to Jennifer Ares (YVWD), Jasmine Orozco Clark (IERCD) and Devin Arciniega (San Bernardino Municipal Water Department) for further discussion on this topic.

- 6. **Discussion of Social Media Campaign.** Director Thompson stated that he has been following the Agency's social media sites and that staff is doing a great job. He noted that we have 267 Instagram followers. Director Thompson mentioned that with Facebook and Instagram we have the ability to pay a service to push out notifications within certain demographics, notifying those individuals of certain minimal events, like a pipe break or catastrophic events such as a major earthquake that has impacted the SWP.
- 7. Discussion of Potential Dedication Ceremony for Fiesta Recharge Facility. At the request of Chairman Thompson, this item was tabled to the next meeting.
- **8. Discussion of State of the Water Supply Event.** At the request of Chairman Thompson, this item was tabled to the next meeting.
