### **MEMORANDUM**

**RE:** Conduct Interviews and Consider Filling the Division 3 Director

Seat on the Board of Directors

**DATE:** February 28, 2022

### **Summary:**

Director Stephen Lehtonen resigned from the Board on January 24, 2022, thereby creating a Board vacancy. At the Board meeting on January 24, 2022, the Board took action to authorize the posting of a Notice of Vacancy and announced that the Board intends to fill the vacancy by appointment.

#### **Recommendations:**

- 1. That the Board conduct interviews of those individuals interested in being appointed to the vacant Board seat; and
- 2. That the Board take action to fill the vacant Board seat.

## **Detailed Report:**

## Letters Of Interest And Time Periods

Letters of interest and/or resumes were required to be delivered or mailed to the Agency so that they would be received no later than February 18, 2022. The letters of interest and/or resumes of individuals interested in the vacant Board seat are enclosed. A person appointed to the office of the Division 3 Director must be a resident of Division 3.

Under Government Code Section 1780, the Board may make an appointment within 60 days after the date of the vacancy. Therefore, the Board has until Friday, March 25, 2022 to fill the Board seat by appointment. If the Board does not reach a decision by the 60-day deadline, then under Government Code Section 1780, the County

Board of Supervisors may appoint a person within 90 days of the date of the vacancy. If the Board of Supervisors does not take up this matter, or cannot reach a decision, then the Agency Board would be required to call an election.

#### DISCUSSION:

## Recommended Interview Procedures

- 1. Order Of Interviewees The order of interviews was determined based on alphabetical order of the candidates' last names.
- 2. Candidates Observing Interviews It is recommended that the Board ask candidates who are not currently being interviewed to not observe the interviews virtually until it is their turn. This is to avoid providing such candidates the advantage of knowing how previous interviews went, topics which were emphasized or de-emphasized, etc. Once a candidate's interview is done, the candidate is welcome to rejoin the meeting virtually and to observe the rest of the interviews. All candidates need to be virtually attending the meeting once the Board begins its deliberations.
- 3. Opening Statements Prior to the beginning of questions, each candidate should be given the opportunity to make a brief opening statement.
- 4. Types Of Questions The purpose of questions should be to inquire as to why the person feels he/she is qualified to sit on the Board and why that person is interested in the position. Questions should be framed in neutral form so as to not advocate a particular position. Solely as a suggestion, the following questions are commonly asked in such interviews. The Board may find these questions helpful in maintaining uniformity and to keep the process moving.
  - (a) The Board generally meets on the 2<sup>nd</sup>, 3<sup>rd</sup> and 4<sup>th</sup> Mondays of each month. Pursuant to the 2022 Board Meeting/Workshop Calendar, Board meetings and Water Conservation & Education Workshop meetings are held at 1:30 pm. The

Finance & Engineering Workshop is held at 6:00 pm. Are you able to make these meetings on a regular basis?

- (b) As a director you have a large constituency made up of stakeholders and agencies; both within your district and within the region. Will you be able to make stakeholder meetings on various days of the week on a regular basis?
- (c) What is your knowledge about the Agency and the services it provides?
- (d) Why do you feel you are qualified to sit on the Board?
- (e) Why do you want to be a Board member and if appointed, what would you rank as your top priorities?

## <u>Deliberation And Action By The Board</u>

Following the interviews, the Board should hold a discussion among themselves to get an idea as to what their impressions are and how they are leaning. No written/secret ballots are allowed. The vote must be verbal so that the public knows how each Director has voted. Right after the Board appoints someone, that person should immediately take the oath of office and begin serving as a member of the Board. The oath and participation can be accomplished virtually.

As with other actions taken by the Board, the action to appoint someone to the vacant Board seat must be taken by at least 4 votes. It is within the discretion of the Board how the vote should take place.

One method is to do a roll call vote and have each Board member state their top two choices. Staff can keep track of the votes and announce the two top candidates. After the Board feels it has fully considered the matter, a roll call vote can be taken again with each Board member stating his one top choice.



# Biography/Resume

Let me start off with this sincere statement, I'm passionate about water issues in California, past, present, and future.

I'm a multi-generation native Californian with a legacy back to the earliest migration of settler to what we now call the Los Angeles Basin. From its earliest days, water issues confronted LA and our family's interests with acquiring, storage, distribution, and use of potable water, as well as, protection against floodwater and erosion. These are part of our family history past down through the generations.

As a product of the Los Angeles Unified School District I learned about the history of Los Angeles with water being part of it. I learned about dam failures and diversion of water from the Owens Valley and Mono Lake. There were the Zanja Madre and the likes of Fred Eaton and William Mulholland that made Los Angeles possible with the availability of water.

My father operated a ski tour business from LA to Mammoth Mountain every weekend during ski season in the 1960's – 70's. We travelled along the route of the LA aqueduct and learned its jaded history in detail over the years. This experience left an indelible imprint about the tenuous relationship with water and living in southern California.

While living in the area now known as Eastvalle in the 1990's, when diary cows outnumbers people, well water contamination was a constant issue due the nitrate levels. A human caused surface and groundwater contamination problem known as the Stringfellow Acid Pits also created issues with potable well water use. There were endless community meetings, lawsuits, and mitigation measures implemented to address the problem in my community.

I own property in Utah where water use is highly regulated and adjudicated under strict adherence water rights use laws. I have to provide the state documentation about water use with dire consequences for failure to comply with reporting cycles.

As a homeowner in Yucaipa, between 2001 and 2020, a flood control channel ran though my property that was subject to a variety of requirements for flood control, protected woodlands, and seasonal waterway with animal habitat conditions and constraints.

In my law enforcement tenure in the 1980's, I was Special Deputy Sheriff with primary responsibility for protecting reservoir systems, wetland habitat, and conservancy lands in southern Orange County from illegal activity and damage.

In my fire service career from 1988-2015, I was the Rancho Cucamonga Fire District agency representative to the City and County's technical review committees within the community development and building and safety departments. I was the fire district's resource to the collaborative plan check and approval process with the Cucamonga Valley Water District for all water systems where fire protection services were a component and included: public fire hydrants, distribution systems, reservoirs, and on-site fire service and systems, including fire pumps and reservoirs.

I was a fire district peace officer and a member of our hazardous materials response team that frequently responded to spills and discharges that threatened or compromised drainages, waterways, basins, flood control channels and facilities, as well as, the broad umbrella of the navigable waters of the US, which pretty much is anything that could make it to the ocean. I was to primary point of contact between an endless number of local, regional, state, tribal, and federal agencies on anything environmental where water was always a threat or consideration.

I participated in the budgetary process as the primary preparer for numerous account and cost centers of the annual comprehensive budget preparation, approval, and spending process for the fire district in these program areas: Fire Prevention, Hazardous Materials, Vegetation Management, Weed Abatement, and many smaller budget areas.

I am the author of many standard operating procedures and policies for a wide range of programs that included operations, prevention, workplace safety, personnel, and EOC operations.

I was a confidential employee that was assigned sensitive, confidential, and multi agency task force functions that routinely involved interaction at the executive and elected official levels, internal and external to the agency, frequently acting for the agency under considerable independence of action.

For many years, I was an elected officer of our labor union with frequent interaction with executive leadership and elected officials at the local, state, and federal levels of government.

I have 3 associate degrees and nearly done with a Bachelors in Fire Service Administration with a minor in homeland Security and Emergency Management.

In 2020, my wife and I relocated from our home in the foothills of Yucaipa for the past 20 years to a slower pace in the Sun Lakes Country Club community for several years now. Previously we lived in Mira Loma for 13 years, making our home in the Inland Empire for nearly 35 years.

I believe that my personal and professional experience, education, and interests gives me the knowledge, skills, and abilities to function at a leadership capacity in an organization and I believe that if given the opportunity to serve as the appointed to the vacant Director seat for Division 3, I would serve the public and the agency with a balanced perspective of reasonable institutional needs and responsibly represent the constituents values in the representative governance process.

In conclusion, California's water supply and delivery system is complicated and needs leadership that can navigate through the challenges to ensure that the served communities get what they need today and well into the future, I believe that I can contribute as part of the team that can make that happen at the San Gorgonio Pass Water Agency.
