

- Grant Support Consultant team onboard
- Small Systems Assistance Program Initiated, can be expanded
- Backbone Infrastructure Study and Design Initiated, ongoing
  - Calimesa Area Recharge Property purchase, ongoing
  - Bunker Hill Banking & Recovery Program Initiated, ongoing
  - Income Study Initiated, ongoing Boardroom Upgrades – Initiated, ongoing
  - Headquarters Improvements Some done, some not
- Local Supplies Acquisition in process, may need additional supply Sites Reservoir – Approved final planning costs Delta Tunnel – Approved final planning costs



### Yucaipa GSA and San Gorgonio GSA

- First major reports were due 1/2022



 Will need ongoing monitoring and reporting to State • Most start up costs covered under existing grants • Both planning areas managed by consultants More involved in the San Gorgonio Pass GSA



### **Infrastructure Plan** (Phase 2)


- First Phase Completed late 2020 (on hold pending 2020 UWMP)
  - See October 12, 2020 Engineering Workshop
- Deals with external projects with regards to local supply
- Identifies liabilities as well as projects/actions needed for future supply
- Will need to be refined based on 2020 UWMP projections and changing landscape in CA water
- Inclusion of respective retailer's UWMP projections may be beneficial

# Grant Support

- State/Fed quickly moving into a funding cycle
- Likely the best opportunity to fund projects over next several years
- Professional grant consultants yield higher degree of success
- Success depends on front-side positioning to locate and fit projects into various funding mechanisms
  - •\$75K
    - Average grant application \$20-25K





### **Federal Advocate**

- Represents Agency to promote support for funding capital improvements
- Important for "Big Ticket" projects
- Used for a specific purpose to garner high-level project support

Grant consultant and advocacy selected. More emphasis will be put on this area now that projects are better defined over the last 2 years

## **Small Systems** Support

Some work in this area has occurred. Could be expanded with willing participants.

- Focuses on local small water systems (many disadvantaged community status)
- Works with established non-profit who caters to work
- Foundational *Technical-Managerial-Financial* (TMF) support
- Conduit between local needs state/federal support (i.e. grants)
- Well established successful and recognized model for support
- Return on investment very high

Initiated but will need additional serious attention and collaboration to keep momentum and time funding cycles.

# **Backbone Pipeline**

- Discussed for many years
- 2020 UWMP and San Gorgonio GSP demonstrate growing need
- Renewed local interest and support
- Potentially materially grant fundable
- Will need:
  - Right-of-Way
  - CEQA/NEPA
  - Alignment and design
  - Financial and grant strategy
- "Shovel Ready" is goal (in phases)


### South Mesa Recharge

- 4-acre multi-purpose basin
- Calimesa, County Flood, SBVMWD, SMWD and SGPWA

Property purchased. Valley District and South Mesa are partnering on the project. Final Design initiated and then pursue grants to construct.



### <u>Three-Party Deal</u> (Bunker Hill)

- Agreement to bank water in Bunker Hill Basin
- Principles of Agreement Drafted
- Some technical challenges
- Will need local support via Valley District's stakeholders

Valley District, YVWD and Pass are actively working on this project. Anticipated outcome is a 20K acre-foot storage account next door.
