SUBJECT: ADOPT RESOLUTION 2022-22 APPROPRIATIONS LIMIT

#### RECOMMENDATION

Adopt Resolution 2022-22, Appropriations Limit for FY 2022-23

### **BACKGROUND**

The Gann Limit was approved by voters on November 6, 1979 and incorporated into the California Constitution in Article XIIIB. Also known as the Appropriations Limit, this bill was intended to keep California legislators from overspending limited tax resources during a time when other voter-approved measures severely limited available tax revenue (think Proposition 13).

Ballot initiatives in 1988 and 1990 weakened the Gann Limit, so that today, the calculation and adoption of the Appropriations Limit by public agencies is considered a housekeeping item, with little or no impact on an agency's ability to disburse tax revenue.

#### **ANALYSIS**

The attached calculation of the Appropriations Limit for the San Gorgonio Pass Water Agency shows that we are limited to spending a bit over \$76 million in FY 2022-23. The combined expenditure budgets for the Agency total a bit over \$36 million, so the Agency is well within the Appropriations Limit.

#### FISCAL IMPACT

There is no fiscal impact as a result of this action.

#### **RESOLUTION NO. 2022-22**

### RESOLUTION OF THE BOARD OF DIRECTORS OF THE SAN GORGONIO PASS WATER AGENCY ESTABLISHING THE APPROPRIATIONS LIMIT FOR FISCAL YEAR 2022-23

**WHEREAS**, Article XIIIB of the California Constitution places an annual limitation upon appropriations from proceeds of taxes by each local government of the State of California; and

**WHEREAS,** Section 7910 of the California Government Code implements Article XIIIB of the California Constitution by requiring each local jurisdiction to establish, by resolution, its appropriations limit for each fiscal year, and to make the documentation used in determining the appropriations limit available to the public fifteen days prior to adoption of the resolution establishing the appropriations limit; and

**WHEREAS,** The San Gorgonio Pass Water Agency has documented its calculations of the Agency's appropriations limit for Fiscal Year 2022-23, and notice of said calculations has been posted on the Agency's outside Bulletin Board (said notice being visible from the public walkway in front of the Agency's building) and the calculations have been made available to the public at least fifteen days prior to the adoption of this resolution;

**NOW, THEREFORE, BE IT RESOLVED,** by the Board of Directors of the San Gorgonio Pass Water Agency as follows:

- 1. The appropriation limit applicable to this Agency pursuant to Article XIIIB of the California Constitution for Fiscal Year 2022-23 is hereby established and determined to be in the sum of \$76,388,514.
- 2. A copy of the documentation used in the determination of the Fiscal Year 2022-23 appropriations limit shall be affixed hereto and shall be available for public inspection.
- 3. Pursuant to Section 7910 of the California Government Code, any judicial action or proceeding to attach, review, set aside, void or annul the establishment of the Fiscal Year 2022-23 appropriations limit as set forth herein must be commenced within forty-five days of the adoption of this resolution.
