Irrigation Workshop at Four Seasons HOA

Upcoming HOA Workshop: The IERCD Education Team is scheduled to present an HOA workshop on behalf of SGPWA for Four Seasons on February 22nd, 2024.

We are expecting 75 residents to attend this workshop. Each resident will receive a California Native plant to grow in their yard, some SGPWA giveaway items, and door prizes. Winner will receive a gift card from Cherry Valley Nursery.



The Landscaping Workshop speaker will be from the Riverside County Master Gardener Cooperative Extension Program. Topics will include irrigation to make yard space more water efficient and water saving tips for the residents attending the workshop. Following this event, a second workshop scheduled for March 28th will provide attendees with an overview of waterwise plant selection, installation, and long-term care and maintenance for ongoing resource conservation and cost savings.

Water Conservation Programming: After a well-deserved Winter break students resumed classes on January 8th. The IERCD Education Team presented 4 Water Conservation Programs, reaching just over 100 students. There are 8 programs scheduled in February 2024, and teachers are currently being contacted for March and April scheduling.

In addition to general educator and campus outreach, the IERCD has been working to identify and schedule bilingual Water Conservation Programs within SGPWA's service area. Preparation for scheduling has included translation of program content into Spanish and distribution of flyers/communication with office staff and teachers at two campuses with bilingual programming. As of this report, the programs have not yet been scheduled; however, this remains a priority for IERCD in the 2023-24 academic year.
