

AT A GLANCE




We reached **244** students this month through our water conservation programming. We have reached **70%** of campuses within SGPWA's service area.

Water-wise and Landscape Workshop at Four Seasons HOA

Four Seasons HOA Workshop: The IERCD Facilitated the second installment of the HOA workshop on behalf of SGPWA for Four Seasons Residents on March 28th, 2024. The residents enjoyed two guest speakers who both shared valuable tips and information on shade trees and water-wise landscaping. Our first speaker, UC Agriculture and Natural Resource, UCANR, Horticulturalist, Janet Hartin, provided residents with information on the various mid-size native shade trees for their yards and how to care for them while still being water efficient. There were lots of questions for Janet which she fully answered and helped attendees to see the value and beauty of these water-wise trees in their yards.

Our second speaker, a Master Gardener with the UC Cooperative Extension, UCCE, Anita Matlock, provided an overview of water-wise plants and shrub selection for residential landscapes with installation, long-term care, and maintenance while providing water-wise and cost-saving ideas. Anita also helped residents understand the best place to plant a larger shrub or tree to not create a challenge for the householder in the future. Each resident received California-native plants, SGPWA giveaway items, and assorted door prizes. The prizes consisted of a Landscape Garden book, a drip irrigation kit, and two gift cards to the Cherry Valley Nursery. The IERCD has facilitated 4 HOA workshops this year on behalf of SGPWA. We will be looking forward to scheduling additional opportunities to share with residents of the SGPWA area in the upcoming year.
