#### A. General Manager's Report

General Manager, Lance Eckhart reported on the following:

- 1. Provided an update on the American Rescue Plan Act (ARPA) Funding for the County Line Road/Heli-Hydrant projects.
- 2. Provided an update on the Steelhead trout issues affecting the Delta and Central Valley; recapped letter by the Department of Water Resources explaining the department's actions during the spring and the challenges they face, with a focus on the Delta Conveyance Project and its potential to provide additional water in the future; Healthy Rivers and Landscapes, 8-year program pilot test to do adaptive management.
- 3. San Gorgonio Pass Water Agency will be sponsoring the August 9, 2024, 18<sup>th</sup> Annual Southern California Water Conference.

The Board discussed and expressed their desires to support advocacy efforts for state-level contracts, and acknowledged staff's active efforts, contributions, and time spent in moving these projects forward.

### B. Legal Counsel's Report

Counsel, Jeff Ferre provided an update on the Sites Reservoir Project and the pending lawsuits which raise challenges to the Environmental Impact Report which was certified for the Project. Counsel Ferre said a hearing is scheduled for May on these writ of mandate actions.
