# Official Minutes Board of Directors Regular Meeting April 21, 2025

## 1. Call to Order, Pledge of Allegiance, and Invocation

The San Gorgonio Pass Water Agency Board of Directors meeting was called to order by Vice President Chander Letulle at 6:00 p.m., Monday, April 21, 2025, at the office of the Agency. Director Sarah Wargo provided the invocation and Treasurer Robert Ybarra led the Pledge of Allegiance.

# 7. Informational Presentations and Updates:

# A. State Water Project Fundamentals - Water Supply Contract Recap

Senior Water Resources Planner Emmett Campbell provided an overview of the Water Supply Contract, outlining the various types of water included in the agreement, such as Table A water, carryover water, and Article 55 water. He noted that the contract has undergone 20 amendments since its inception in 1962. The most recent amendments extend the contract through 2085 and introduce provisions that facilitate increased flexibility in water transfers and exchanges.

# **B.** Water Conditions Report

Operations Manager Matt Howard presented the April water conditions report, noting that precipitation levels in the northern Sierra are currently above average. He provided an update on the status of Lake Oroville and San Luis Reservoir, emphasizing the effects of snowpack melt on storage levels. Mr. Howard also offered a detailed analysis of Delta outflow data, illustrating the volume of water exiting the Delta and its implications for overall water management. Additionally, he addressed the anticipated water deliveries and underscored the critical importance of maintaining recharge facilities to support ongoing water supply reliability.

# C. USGS Drilling Monitoring Wells Project Update

Operations Manager Matt Howard provided an update on the U.S. Geological Survey (USGS) monitoring well drilling project, including the current progress at Site P1. He outlined the project's primary objectives, which involve

collecting groundwater level and water quality data to support the Groundwater Sustainability Plan. Mr. Howard also discussed the partnership with the City of Banning for the disposal of drilling mud and noted the projected completion timeline for the remaining well sites. He emphasized the project's significance in advancing groundwater management efforts and highlighted cost-saving strategies that have been implemented to enhance overall efficiency.

# D. Procurement Policy Required Notification: Contract with K-Vac Environmental Services, Inc., in the amount of \$44,795.11, for Mud Hauling at USGS Well Drilling Site

Chief Financial Officer Thomas Todd Jr. provided background information on the contract with K-Vac Environmental Services, Inc., noting that the company submitted the lowest responsible bid. He confirmed that the contract falls within the budgeted allocation for monitoring well drilling. Mr. Todd acknowledged the limited notice given by the U.S. Geological Survey regarding the drilling schedule and commended the agency's prompt response. He further noted that the project is funded through a grant from the Department of Water Resources (DWR), with financial responsibilities prorated among the Groundwater Sustainability Agency (GSA) member agencies.
